## CERTIFICATE OF SPAIN WIND FARMS

The certificate DPEE is created with the idea of promoting activities among the group in radio amateur while publicizing the places in Spain where wind farms are located. It is governed by the following rules:

- 1 The same can access all licensed radio amateurs in possession of official and listeners (SWL). It encourages all amateurs to make contacts and activations from wind farms in Spain. It will be internationally.
- 2 The certificate shall be issued in three categories (BRONZE-SILVER-GOLD), being able to make contacts with the various wind farms in any band and mode authorized by law. Not valid contacts made in bands and or modes cross, or contacts made from stations / AA (Air mobile). To obtain the certificate in their ranks, the applicant must prove by QSL card (\*) have contacted the next number of different wind farms:

BRONZE - 75 references confirmed SILVER - 150 references confirmed GOLD - 300 references confirmed

On the website of DPEE will HONOR ROLL with the hallmarks of those participants that once they get the certificate in the Gold category with the highest number of confirmed references.

- 3 They will be valid from contacts made with stations and portable, laptops and mobile if duly authorized to do so. The DPEE will take effect from the date: 15-July-2011
- 4 The expeditionary station shall transmit from up to 500 meters from the outer edge of the grounds of the wind farm in case you can not do it from inside. It is the responsibility of activating station:
- --- Provided appropriate permissions for activation of a wind farm park, should be required
- ---Respect the facilities where the activity will develop and comply with safety standards and also with common sense.
- --- Do not install antennas and equipment near or under the turbines and not near or under power lines. Attention also possible lightning strikes and the presence of free animals.
- --- Being a natural stop site activation as it was before their arrival and if necessary better than it was.
- --- If appropriate, inform the local authorities activation or law enforcement authorities (advisable).
- --- It is recommended to stop or suspend activation to any hint of risk.

- 5 Only valid activation per day with the same call and at the end it will be mandatory to send the log of contacts the manager of the certificate, by e-mail and an attachment in Excel or Cabrillo. Include log at the beginning of the callsigns of all operators for the reference shall be credited on. The log will be accompanied by a copy of the authorization (if it available), pictures or videos, where they see a clear reference and used equipment or antennas, or operators. The photos and videos will become property of the organizer of the certificate, giving the station activating the rights of the images for the development and management of the certificate. It is recommended to add text to photos with the indicative reference and date of activation. The organizer edit photographs if necessary, adding thereto the necessary text data with activation.
- 6 For a trigger is accepted as valid must be made a minimum of 50 contacts, being able to complete this amount on successive days to complete the minimum required. The deadline of sending the activation log will be 30 days from the date of the activity, after this date will not be validated activity, except for just cause. After sending the log, it can not be modified with new inclusions indicative unless corrections taken wrongly, so promoters are requested to carefully review their log's before sending. After 6 months, not admit any modification.
- 7 A trigger to grab stations perform a minimum of 25 activations valid, they email you a certificate activator in recognition of his work.
- 8 will be issued in digital format and will be sent free of charge by email, to be printed by the applicant. If someone prefers printed on paper, will have to pay along with the application the amount of 5 Euros to cover the cost of printing and mailing.
- 9 For the application will not be necessary to send QSL cards, but a list of all contacts and incorporating the station callsign expeditionary active reference, date, time, band and mode. This list shall be signed by the applicant and also stamped and signed by the president of a radio club or with the signing of two amateurs. In the previous three cases, the signatories undertake to ensure that each of the statements listed is duly confirmed by the corresponding QSL card. On the web you can download an application form.

Also accepted the use eQSL card or electronic qsl, They shall be the reference activated. In this case the applicant has to send email with the application of each eQSL photographs.

In the case of contacts made with triggers that have political as he did not send your QSL card activations, the applicant may submit to trigger a list of contacts made between the two. The activator finds that the contacts on the list contained in their log's and immediately send by email a copy of that list to the manager, stating therein that the relationship between the two is correct contacts. The activator also notify the applicant that the list is already held by the manager. At this point, the applicant may send the manager a list of all the contacts you want proof, indicating in each case if confirmed with QSL card or belong to a certified list.

Of having to make use of lists certified mail, sent to the applicant within the same trigger on the list, another blank on the same dimensions and number of stamps needed to send the trigger to wishlist manager. Want to get too trigger response, the applicant will have to send another envelope and sufficient postage for the trigger to respond.

Also include the image is accepted or photocopies of licenses ham. All applications and inquiries will be duly considered and addressed.

- 11 With thanks to all radio amateurs to have updated the nomenclature of the certificate, being well received proposals for amendments thereto, including new references or possibly terminate those who somehow do not deserve to be in the same. Thanks also notifying the manager of the geographic coordinates for the location of those wind farms that do not have coordinates in the gazetteer.
- 12 The present regulations may be changed as the development of the certificate so requires, any issue that is not reflected in these rules shall be decided by the manager.

In the event that the certificate management has to change hands, the manager offered to manage the person or group of amateurs who wish to and are committed to maintain and control.

## 13 - References will be assigned as follows:

In all cases the initials PE (Wind Farm), followed by the letter of the relevant province, plus the reference number given. For example the reference number will be one of Madrid: PEM-001, the Pontevedra PEPO-001, and so on with all the provinces that have wind farms.

It is possible that a wind farm in the gazetteer referenced this still under construction or fulfilling any administrative requirement for commissioning. In these cases, if at least one wind turbine will be installed activation although the turbine is not operating.

- 14 In the gazetteer and accompanying reference of each wind farm is included a reference to the DME (Certificate Municipalities of Spain), not meaning this detail that this data is final, because the same park can be installed or cover several municipalities. The trigger, if it deems necessary in these cases should give the DME reference corresponding to where you place your station.
- 15 On the web the diploma will be a list of references activated, another with the callsigns of stations and other activating awarded with certificates.
